

QARAYA End User License Agreement (EULA)

This End User License Agreement ("Agreement") is a legal agreement between you ("User") and **Qaraya**, a company based in the Netherlands, governing your use of the QARAYA mobile application (the "App").

By downloading, installing, or using QARAYA, you agree to be bound by the terms of this Agreement. If you do not agree, do not use the App.

1. LICENSE GRANT

Qaraya grants you a **limited, non-exclusive, non-transferable, revocable license** to install and use QARAYA on your personal mobile device for non-commercial, educational, and entertainment purposes only.

You may not:

- Copy, modify, distribute, or reverse engineer any part of the App;
 - Use the App for commercial purposes or in violation of moral or religious norms;
 - Rent, lease, or sublicense the App to others;
 - Circumvent technical protections or exploit the QAR token system unfairly.

QARAYA includes Quranic verses and religious symbols presented respectfully for educational purposes. Users may not misuse or distort this content.

3. TOKENS AND REWARDS

The App includes optional access to **QAR tokens**, which are blockchain-based game rewards. Earning or minting these tokens is governed by in-game behavior and achievement. Qaraya does not guarantee value, convertibility, or financial gain through token usage.

You are responsible for any blockchain wallet linked to your account and must comply with your local financial and legal regulations.

4. UPDATES AND MODIFICATIONS

Qaraya may update the App or modify its content at any time. This license applies to all future updates unless explicitly replaced. Qaraya is not obligated to provide any support, updates, or bug fixes.

5. TERMINATION

This license is effective until terminated. It will terminate automatically if:

- You violate this Agreement;
- You delete the App or request account deletion;
- Qaraya discontinues the App or revokes access due to misconduct.

Upon termination, you must cease all use of the App and delete it from your device.

The App is provided "as is" without warranties of any kind. Qaraya makes no guarantees about accuracy, reliability, uninterrupted access, or fitness for a particular purpose.

You use QARAYA at your own risk. We do not accept liability for gameplay errors, loss of progress, or token-related losses.
